#### **Historical Note:**

This collection focuses on Charles Parton and his wife Teena. They moved to the Island in 1977, and in 1980 bought Alley's General Store. Charles Parton had lived in Connecticut and had a practice in pediatric surgery. He also taught public health and community medicine at the University of Connecticut and University of Hartford. It was in Hartford that he met his future wife. Teena had summered on Martha's Vineyard beginning in the late 1950's and began bringing Charles in the 1970's. While neither had a background in store management, they became interested in purchasing the General Store. In 1980 they bought Alley's from James and John Alley and their sister, Phyllis. In 1992 Charles Parton and Teena gave up the business and moved to North Carolina. In the same year, Charles published *From Sanderson's to Alley's General Store*, a history of the store.

### **Scope and Content Note:**

The Charles Parton Collection is a mix of personal papers, research notes, maps, correspondence, photos, and public documents. These materials were acquired during Parton's research for the book *From Sanderson's to Alley's Store*.
